



The Anne Kingsley- Highland Hospital 2024 College Scholarship

Anne Kingsley was a Highland Hospital Credit Union Employee who passed away in May 2007 only months after retiring. This scholarship was created for Highland employees and their family members who have an AFCU Membership.

Eligibility

To be eligible to apply for the scholarship:

- All applicants must be a relative of a Highland employee and a high school senior or college student for the 2023/2024 school year.
- Must be a current member with an open Student Checking account at Advantage FCU.
- Must complete a Scholarship application and essay.
- Must plan to attend or be currently enrolled in an accredited college or university in the 2024 school year.

Selection Process

The winners will be selected by an independent panel of judges responsible for evaluating and ranking applications received within three separate categories – Academic Performance, Community Involvement (includes sports, volunteer work and activities outside of the standard school curriculum) and an Essay Response. One \$1,000 scholarships will be awarded.

Application Process

To apply, student members must complete this scholarship application in full. Please attach one (1) additional sheet to your application containing your essay response and a copy of your Activities/Extra Curricular/Community Service Resume. Failure to complete the application and include all applicable attachments as instructed will result in disqualification.

- The signed application must be submitted to the address below, along with:
 - An official copy of the student's SAT and/or ACT scores (when applicable)
 - Please DO NOT send original
 - An official copy of the student's high school transcript (SAT, ACT scores may be included on transcript)
 - Note: If required by the applicant's high school, this item can be mailed directly from the guidance office. It is the student's responsibility to ensure that their school transcripts have been submitted.
