



# Advantage Federal Credit Union 2024 College Scholarship Program

## Eligibility

*To be eligible to apply for the scholarship:*

- Must be a current member of Advantage FCU with a Student Checking account in their own name and members must be in good standing with Advantage FCU.
- All applicants must be a high school senior for the 2023/2024 school year.
- Must complete a Scholarship application and essay.
- Must plan to attend an accredited college or university in the 2024 school year.

## Selection Process

The winners will be selected by an independent panel of judges responsible for evaluating and ranking applications received within three separate categories – Academic Performance, Community Involvement (includes sports, volunteer work and activities outside of the standard school curriculum) and an Essay Response. Four \$1,000 scholarships will be awarded.

## Application Process

To apply, student members must complete this scholarship application in full. Please attach one (1) additional sheet to your application containing your essay response and a copy of your Activities/Extra Curricular/Community Service Resume. Failure to complete the application and include all applicable attachments as instructed will result in disqualification.

- The signed application must be submitted to the address below, along with:
  - An official copy of the student's SAT and/or ACT scores (when applicable)
    - Please DO NOT send original
  - An official copy of the student's high school transcript (SAT, ACT scores may be included on transcript)
    - Note: If required by the applicant's high school, this item can be mailed directly from the guidance office. It is the student's responsibility to ensure that their school transcripts have been submitted.
